SGCC Meets with Canawaima Ferry Service -Bridging the Gap for Enhanced Cross-Border Connectivity

The Suriname-Guyana Chamber of Commerce (SGCC) is pleased to share insights from a recent meeting with Mrs. Prashad, Deputy Terminal Manager of the Canawaima Ferry Service. This dialogue highlighted the vital role the ferry plays in connecting Suriname and Guyana, facilitating trade, tourism, and daily life for both Suriname And Guyana.

KEY TAKEAWAYS

- Bridging the Information Gap: The meeting emphasized the need for improved communication between the ferry service and its users. Many are unaware of the vehicle capacity limit of 23, which can be further reduced when accommodating trucks.
- Addressing Delays: The ferry service prioritizes vehicles for the next crossing based on arrival order to manage wait times. Additionally, extra trips may be offered depending on the number of waiting vehicles.
- Introducing Online Booking: Recognizing the current system's limitations, the Canawaima Ferry Management plans to implement a comprehensive online booking platform soon. This initiative aims to streamline operations, improve service efficiency, and enhance cross-border trade and travel.
- SGCC's Commitment to Collaboration: The SGCC remains dedicated to working closely with the ferry management team to ensure the successful implementation of these initiatives. This collaboration underscores our commitment to fostering improved connectivity and service quality for all stakeholders.
