ADVOCACY



The SGCC is actively lobbying to address three critical issues impacting trade and connectivity between Suriname and Guyana. Recognizing the importance of these matters for regional economic growth, the SGCC has made recommendations and is willing to join working groups for effective resolution.

- 1. Implementation of an Online Booking System for Canawaima Ferry Service
- Discussion Outcome: Urgent need for coordinated online booking system implementation.
- Benefits:
 - Increased government revenue from streamlined booking processes.
 - Reduced waiting times, allowing for 3-4 trips per day instead of one.
 - Elimination of long waiting lines, enhancing passenger satisfaction.
- Action: SGCC calls for communication and collaboration between boards of both countries.
- 2. Finalization of the Double Taxation Agreement
 - Current Status: Seeking Suriname's position on the agreement.
 - Benefits:
 - Increased investment by avoiding double taxation.
 - Enhanced trade relations through simplified tax regulations.
 - Boosted business confidence with clear tax policies.
 - o Improved administrative efficiency for cross-border businesses.
 - Action: SGCC emphasizes urgency in finalizing the agreement.
- 3. Collaboration on Local Content Policies
 - Proposal: Facilitate a meeting between Guyana's and Suriname's local content secretariats.
 - Benefits:
 - Knowledge transfer from Guyana's robust local content policies.
 - Economic development through local business participation in major projects.
 - Capacity building for Suriname's local content secretariat.
 - Action: SGCC recommends forming working groups with relevant ministries and stakeholders.

The SGCC is committed to supporting and participating in these working groups to ensure successful resolutions.

GUYANA PORT INC. TO LAUNCH DREDGING AND SHIPBUILDING SERVICES WITH US\$40 MILLION INVESTMENT

The Suriname Guyana Chamber of Commerce (SGCC) proudly highlights significant advancements by one of its directors, Pritipaul Singh Jr., Managing Director of Guyana Port Inc. (GPI). GPI is launching dredging and shipbuilding services, marking a substantial US\$40 million investment to bolster Guyana's maritime infrastructure.

In a recent Energy Perspectives Podcast episode, Singh detailed GPI's strategic initiatives and investments since 2019. The company has invested between US\$4 million and US\$5 million in the ship repair market, offering services such as blasting, painting, and various mechanical repairs to local and international clients.

Strategic Growth and Customer Satisfaction

GPI's ISO certification and prime location near the Demerara River underscore its commitment to customer satisfaction and long-term relationships. Singh emphasized, "It's not just about delivering a service. It's making sure that the client is satisfied at the end of the day."

GPI invests US\$100,000 to US\$115,000 annually in workforce training, currently employing around 90 individuals, with 10 more jobs to be created through new dredging services. The company emphasizes quality management, health, and safety, and collaborates with PMD Offshore Limited to meet rising ship repair demands.

GPI plans to construct a 5,000 gross-tonnes dry dock, a US\$35 million project set to be completed over 18 months, and invest US\$5 million to initiate dredging services. These efforts aim to support the increased demand for maritime services due to substantial offshore oil reserves.

Pritipaul Singh Jr. exemplifies the innovative spirit and leadership that the SGCC promotes. The SGCC supports GPI's endeavors and anticipates a positive impact on Guyana's maritime industry and economic growth.
